DNC National Committeewoman and National Committeeman 2020 Elections and Nomination Form

Deadlines and Process

- I. All candidates for National Committeewoman and National Committeeman must be registered Democrats as of February 1, 2020 and have resided in their county for at least 30 days from the filing deadline.
- II. Candidates for National Committeewoman and National Committeeman must declare their intent to run by filling out the online form available on the NV Dems website by **10:00 a.m. on Friday, May 29, 2020**. Declarations will not be accepted after that date and time.
 - a. Forms must be e-mailed to: nominations@nvdeems.com
- III. Voting is limited to current members in good standing of the 2018-2020 Nevada State Democratic Party Central Committee.
- IV. Individuals may hold only one voting position on the board at a time. In the event that an individual runs for both DNC representative and Executive Board and wins both of them, the DNC position shall be the one awarded and the Executive Board position shall be awarded to the person with the next highest number of votes in that race.
- V. All members of the State Central Committee will be sent a secure Google form along with an identifying passphrase that will be required to cast their vote.
 - a. All ballots will be sent on **June 13 by 6:00 a.m.** with the election process running until **June 13 at 6 p.m.**
 - b. Phone voting will be an option for members who are unable to vote via Google form.
- VI. The top vote earner for DNC Committeewoman and DNC Committeeman shall be elected DNC Committeewoman and DNC Committeeman.
- VII. In the case of a tie, the winner shall be chosen by a draw of cards, with aces being high. The suit preference shall be clubs (lowest), followed by diamonds, hearts, and spades (highest).
- VIII. Election results will be posted on the NV Dems website by **June 13 at 8 p.m.**

Campaigning

- I. Nomination forms shall be distributed to the 2018-2020 Nevada State Democratic Party Central Committee members no later than Saturday, May 30, 2020 at 5:00 p.m.
- II. Other Communications with NSDP Central Committee shall be sent by the NSDP or Convention Secretary.
- III. All candidates will have an opportunity to send up to three messages in support of their candidacy to delegates, either written (with a maximum of 250 words), or a video statement of 2 minutes or less. Captioned videos are requested for accessibility.
 - a. The first group of messages shall be submitted to the NSDP by Tuesday, June 1, 2020, at 5:00 p.m., and shall be sent to the delegates no later than Thursday, June 3, 2020.
 - b. The second group of messages shall be submitted to the NSDP by Friday, June 5, 2020, at 5:00 p.m., and shall be sent to the delegates no later than Sunday, June 7, 2020.
 - c. The third group of messages shall be submitted to the NSDP by Monday, June 8, 2020, at 5:00 p.m., and shall be sent to the delegates no later than Sunday, June 10, 2020.
 - d. These messages shall be e-mailed to nominations@nvdems.com by the deadline and contain "email communication to delegates" in the subject line. The messages shall also contain the candidate's name and the position the candidate is seeking.

Elections:

- I. Elections shall be conducted pursuant to the Rules of the 2020 Nevada State Democratic Convention.
- II. The election of National Committeewoman and National Committeeman will occur on June 13, 2020 through a remote voting process using secure Google Forms.

Challenges:

- I. Challenges to National Committeewoman and National Committeeman elections shall be decided by the Rules and Bylaws Committee of the Nevada State Democratic Party and must be brought by 5:00 p.m. on June 14, 2020.
