## 2020 STATE CONVENTION

### Nevada State Democratic Party 2020 Executive Board Elections and Nomination Form

#### DEADLINES:

##### I. NSDP Elections

- a. All candidates for At-Large member of the NSDP Executive Board must be registered Democrats as of February 1, 2020 and reside in their county for at least 30 days.
- b. Per the Charter At-Large members to the Executive Board shall not exceed 14. The regional breakdown is as follows: Eight (8) must be from Clark County; Four (4) must be from Washoe County; Two (2) must be from the remaining rural counties.
- c. All candidates shall file their intent to run as an At-Large member of the Executive Board by **10:00 a.m. on Friday, May 29, 2020.**
- d. The nomination forms must be received at the NSDP office by Friday, May 29, 2020 at 10:00 a.m. to be considered a candidate for election. Per the convention rules, all candidates meeting the filing deadline shall be considered nominated candidates.
- e. Forms must be e-mailed to: [nominations@nvdems.com](mailto:nominations@nvdems.com)
- f. There shall not be an opportunity to run as a write-in candidate. In the event no person files for one of the offices one week prior to the deadline, notice shall be sent out to the delegates.
- g. Individuals may hold only one voting position on the board at a time. In the event that an individual runs for both Executive Board and DNC representative and wins both of them, the DNC position shall be the one awarded and the Executive Board position shall be awarded to the person with the next highest number of votes in that race.

## **CAMPAIGNING**

- I. Nomination forms shall be distributed to the delegates no later than Saturday, May 30, 2020 at 5:00 p.m.
- II. Other Communications with the delegates shall be sent by the NSDP or Convention Secretary.
- III. All candidates will have an opportunity to send up to three messages in support of their candidacy to delegates, either written (with a maximum of 250 words), or a video statement of 2 minutes or less. Captioned videos are requested for accessibility.
  - a. The first group of messages shall be submitted to the NSDP by Tuesday, June 1, 2020, at 5:00 p.m., and shall be sent to the delegates no later than Thursday, June 3, 2020.
  - b. The second group of messages shall be submitted to the NSDP by Friday, June 5, 2020, at 5:00 p.m., and shall be sent to the delegates no later than Sunday, June 7, 2020.
  - c. The third group of messages shall be submitted to the NSDP by Monday, June 8, 2020, at 5:00 p.m., and shall be sent to the delegates no later than Sunday, June 10, 2020.
  - d. These messages shall be e-mailed to [nominations@nvdem.com](mailto:nominations@nvdem.com) by the deadline and contain "email communication to delegates" in the subject line. The messages shall also contain the candidate's name and the position the candidate is seeking.

## **ELECTIONS:**

- I. Elections shall be conducted pursuant to the Rules of the 2020 Nevada State Democratic Convention.
- II. The election of At-Large Members to the Nevada State Democratic Party Executive Board will occur June 13, 2020 through a remote voting process using secure Google Forms.
  - a. Delegates from Clark County, Washoe County, and the Rural Counties will cast votes only for candidates from their respective region.

## **CHALLENGES:**

- I. Challenges to Executive Board elections shall be decided by the Rules and Bylaws Committee of the Nevada State Democratic Party and must be brought by 5:00 p.m. on June 14, 2020.
