# Minutes of the Nevada State Democratic Party Central Committee Meeting

November 18, 2023 Sparks Library Reno, Nevada

Chair Daniele Monroe Moreno called the meeting to order at 1:05 pm and led the Pledge of Allegiance

Chair Monroe Moreno appointed Vice Chair Daniel Corona as Temporary Secretary, due to Secretary Brock's absence

SCC Member Teresa Melendez made the Tribal Land Acknowledgement

Chair Monroe Moreno reviewed meeting rules and procedures and introduced SCC Member Tim Hanifan as Sergeant at Arms

Virtual Meeting Moderator Jordy Barry reviewed virtual meeting procedures

Chair Monroe-Moreno accepted the below corrections to the September minutes, and the minutes were filed.

Corrections to September E Board Meeting Minutes, brought to attention by SCC Member Michael Greedy:

- Mr Greedy's Corrections are as such:
  - Believes the minutes are incomplete because none of the notes mention a seconder
  - Also states Motion 1 and Motion 2 are improper / recorded wrong
- Parliamentarian's Reponse:
  - There is <u>no</u> need to include a second, if it was given in the moment. It is okay to not list a second as long as proper process was followed. Simply stating a motion was seconded will suffice.
  - If motions are made from the floor, there is no need to include debate notes - minutes are a reflection of what happened, not what was said.
  - Advised that moving forward the Secretary should link filed motions to the meeting minutes that are posted online after an SCC Meeting.
  - It was noted that the Secretary will amend our previous minutes and republish online

Chair opened the meeting to questions on reports for a 10 minute period

- The Following Questions were asked:
  - SCC Member Matt Fonken asked which 5 states will we be sharing hotel with Nevada at the DNC Convention
    - The Executive Director stated Oregon, Washington, Nevada, Colorado, New Hampshire and New Jersey will be staying at the same hotel as the Nevada Delegation.
  - How do SCC members get in touch with the LGBTQ+ Caucus Chair or other constituency chairs?
    - The Executive Director stated that we will post this information onto the website very soon and will also start to have information available at all SCC meetings moving forward.
  - SCC Member Judith Whitmer asked if DEMs meetings will be in person or virtual?
    - The Executive Director stated that any Assembly District over 50 square miles will be virtual only, any under 50 square miles will be in person only.

Chair Monroe-Moreno wrapped Officer Questions and moved to review motions.

# Motion #1 West/Feldman (Motion to Charter a Senior Caucus)

Artie Blanco (Rules & Bylaws Committee member) gave a committee report stating that the RBC & E-Board Recommended Passage of this motion. Artie Blanco - Motion, Committee- Second

Debate and Questions:

SCC Member Judith Whitmer asked if caucus has met all obligations

Chair confirmed they have

SCC Member Matt Fonken stands in support of Senior Caucus

SCC Member Ms. Roberts asked for a point of information: What is the minimum age to join?

Chair: Caucus has indicated 65 is the current minimum but caucus has indicated matter is under review.

Mr Williams (Virtual) stands in support of the Senior Caucus, and wants to work with the caucus to lower the minimum age to 60.

# Motion #2 Greedy/Sanada (Motion for Unique URLs)

Tech Committee Chair Tanner Hale gave a <u>Committee Report</u> recommending against Motion #2 as SCC members already receive an individual Zoom link & doesn't need to be included in bylaws.

It was stated that both the Tech Committee & Executive Board have both recommended against motion

SCC Member Michael Greedy (Maker of motion): Would like to withdraw his motion. Passed without objection.

No vote was taken.

# Motion #3 Greedy/Sanada (Motion on Remote Meeting Participation)

Chair Monroe Moreno stated that the motion was ruled out of order at 11/17 E-Board Meeting as language needs to be clarified in order to add into the SCC Rules and Bylaws and recommended that the maker of the motion work with Tech Committee & RBC in order to clarify language before bringing back to SCC for vote.

SCC Member Michael Greedy: Seeking clarification as motion was intended to be a standing Rule & not Bylaws change.

Chair: Standing rules are rules & therefore for recommended to RBC

SCC Member Judith Whitmer: This has been an issue in the past with verifying attendance & supports finding a solution to this issue.

No vote was taken.

# Motion #4 Frankoff/Feldman (Motion to Charter Jewish Caucus)

Artie Blanco (Rules and Bylaws Committee Member) gave a Committee Report that the Motion did not meet 60 day notice requirement for Rules & Bylaws amendments. Stated that the RBC will take a vote at the February meeting. RBC is currently working with Maker of the Motion, SCC Member Richard Frankoff, to assist Jewish Caucus with their creation.

Motion was out of order and no vote was taken.

Motion #5 Mahler/Miller (Resolution for David Pritchett)

Executive Director Hilary Barrett stated that the E-Board voted to recommend passage of this resolution at the 11/17 E-Board meeting.
